**NOTICE OF SUCCESSOR AGENT AND  
APPOINTMENT OF SUCCESSOR TRUSTEE UNDER DEED OF TRUST**

THIS NOTICE OF SUCCESSOR AGENT AND APPOINTMENT OF SUCCESSOR TRUSTEE UNDER DEED OF TRUST (this "Notice") is dated as of June 1, 2009 (the "Effective Date"), and is made by COMERICA BANK, individually and as administrative agent for the lenders ("Banks") from time to time party to the Loan Agreement (as hereinafter defined) (in such capacity, "Agent"). Any term not otherwise defined herein shall have the meaning set forth in the Loan Agreement.

1. NOTICE. Agent hereby provides record notice of the following:


A. JPMorgan Chase Bank, N.A., individually and as agent ("Chase"), the lenders party thereto, and Gulf Coast Package, Ltd., a Texas limited partnership ("Borrower") entered into that certain Restated Loan Agreement dated as of November 1, 2000, as amended by the First Amendment to Loan Agreement dated as of July 1, 2002, the Second Amendment to Restated Loan Agreement dated as of August 11, 2003, the Third Amendment to Restated Loan Agreement dated as of December 29, 2004, the Fourth Amendment to Restated Loan Agreement dated as of December 30, 2005, the Fifth Amendment to Restated Loan Agreement dated as of January 5, 2007, and the Sixth Amendment to Restated Loan Agreement, Waiver and Designation of Borrowing Base dated as of June 25, 2007 (such agreement, together with all amendments and restatements, the "Existing Loan Agreement").

B. Chase, Borrower and Eland Energy, Inc., a Texas corporation ("Eland", together with Borrower, collectively, "Grantor", whether one or more) entered into those certain deeds of trust more particularly described on Exhibit A attached hereto and incorporated herein (as amended, collectively, the "Deeds of Trust").

C. By that certain Assignment and Acceptance Agreement (the "Assignment") dated as of even date herewith, Chase sold and assigned to Comerica Bank one hundred percent (100%) of the outstanding rights and obligations under the Existing Loan Agreement and the other Loan Documents (as such term is defined in the Existing Loan Agreement), including, without limitation, all of the rights and obligations under the Deeds of Trust.

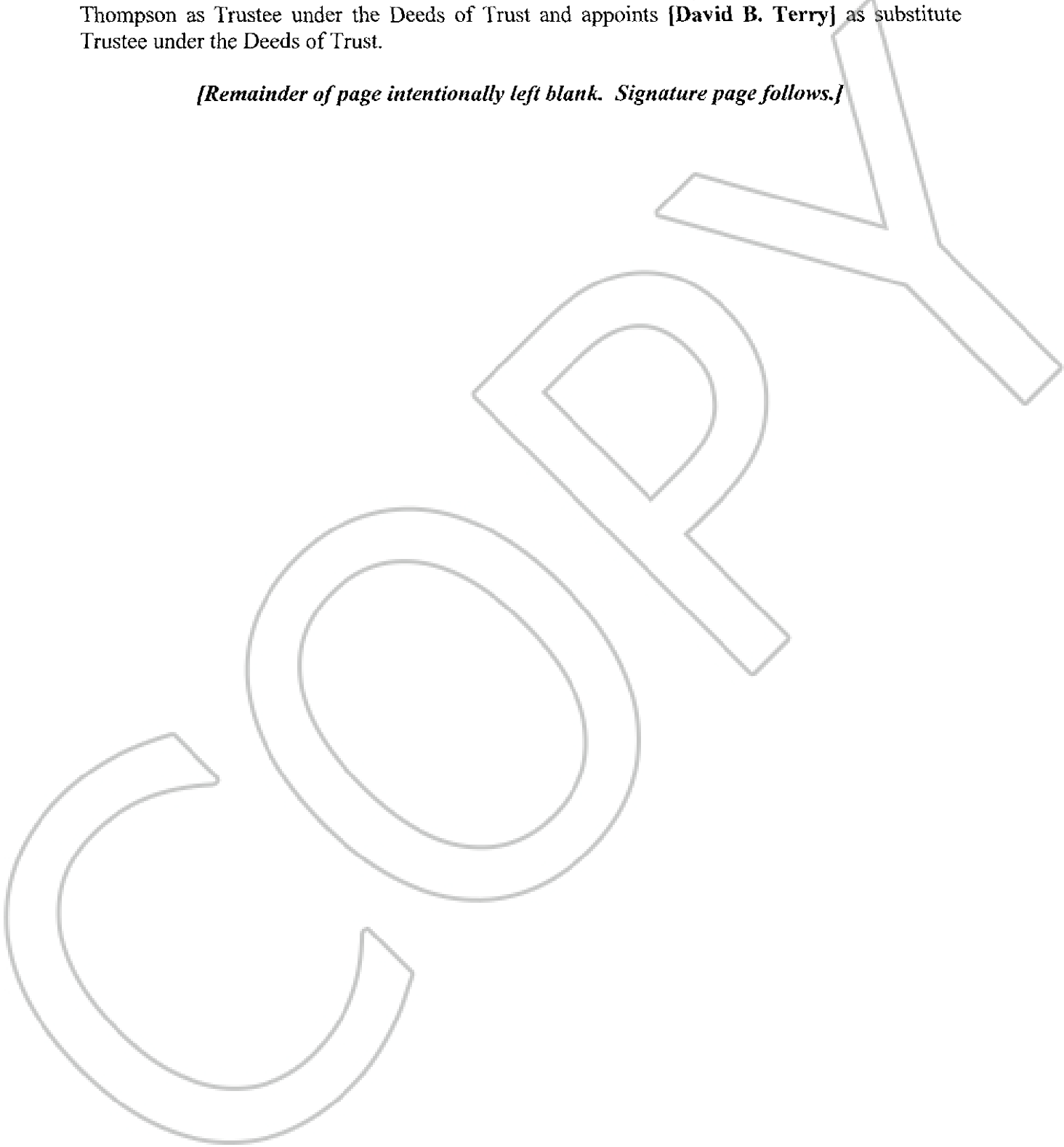
D. By that certain Resignation of Agent and Appointment of Successor Agent (the "Resignation and Appointment") dated as of even date herewith, Chase appointed Comerica Bank as Successor Agent (as such term is defined in the Resignation and Appointment) under the Existing Loan Agreement.

E. Agent, Banks and Gulf Coast have amended and restated the Existing Loan Agreement in its entirety by that certain Second Amended and Restated Loan Agreement dated as of even date herewith (as amended, modified, supplemented and restated from time to time, the "Loan Agreement").





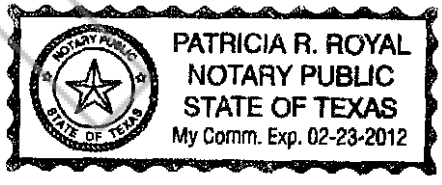
