**SHORT FORM
OF
AGRICULTURAL LEASE**

5. ADDITIONAL TERMS. Additional terms and conditions are contained in the full agreement between the parties. This Short Form shall not modify said agreement.

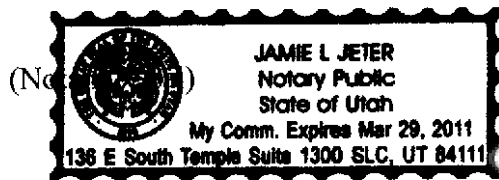
