**TERMINATION OF
DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS
FOR SECTION 5 TOWNSHIP 32N RANGE 51E M.D.B.&M., EUREKA COUNTY, NEVADA**

This Termination of Declaration of Covenants, Conditions and Restrictions for Section 5 Township 32N Range 51E M.D.B.&M., Eureka County, Nevada, dated effective as of July ____, 2009, is entered into by RLF Nevada Properties, LLC, a Colorado limited liability company, with an address of 619 N. Cascade Ave., Suite 200, Colorado Springs, CO 80903 ("RLF Nevada").

A. RLF Nevada is the current owner of that certain real property legally described as Section 5, Township 32 North, Range 51 East, M.D.B.&M., Eureka County, Nevada (the "Property").
