17 This matter came on regularly for a hearing before the Court based on the Amended
18 Notice of Deficiency Judgment and Default Judgment filed by the Plaintiff. All proper notices
19 with respect to the Notice of Hearing were provided to the Defendant. Entry of Default was
20 made against Defendant, DUGAN ENTERPRISES, LLC, on February 27, 2009. Notice of
21 Entry of Default was served on Defendant on March 3, 2009. John Gourley, Managing Member
22 of RUBY HILL RANCH, LLC, a Nevada Limited Liability Company, appeared on behalf of the
23 Plaintiff, along with his attorney, Gary E. Di Grazia, Esq., of GOICOCHEA, DI GRAZIA,
24 COYLE & STANTON, LTD. No representative or attorney appeared on behalf of Defendant,
25 DUGAN ENTERPRISES, LLC.

26 Evidence was presented to this Court showing the fair market value of the property sold
27 as of the date of the foreclosure sale. The Court, having reviewed the evidence, and good cause
28 appearing, hereby ORDERS, ADJUDGES AND DECREES as follows:

1 1. The above-entitled Court has jurisdiction over the parties and in the subject matter
2 contained in Plaintiff's Complaint for Deficiency Judgment and Declaratory Relief.

3 2. A Deficiency Judgment is granted against the Defendant, DUGAN
4 ENTERPRISES, LLC, a Nevada Limited Liability Company, in favor of RUBY HILL RANCH,
5 LLC, a Nevada Limited Liability Company, in the amount of Ninety-Five Thousand, Eighty-Six
6 and 07/100ths Dollars (\$95,086.07), which the Court finds is the amount by which the
7 indebtedness which was secured exceeds the fair market value of the property sold at the time of
8 the foreclosure sale.

9 3. The Court hereby declares that the Plaintiff acquired all right, title and interest in
10 the Lease Agreement between Ruby Hill Ranch, LLC and Owen Miller and Chryle Miller, his
11 wife.

12 4. The Court declares that Plaintiff reacquired all right, title and interest in the
13 Amended Water Supply Agreement between William A. Crane and John Gourley and Ruby Hill
14 Ranch, LLC, jointly and severally, and Devil's Gate Improvement District, a political
15 subdivision of the State of Nevada, which Agreement is recorded in Book 439, page 339-344 in
16 the Official Records of Eureka County, Nevada.


17 5. Plaintiff is entitled to reasonable attorney fees in the amount of \$5,012.00.

18 6. Plaintiff is entitled to costs in the amount of \$246.74.

19 7. Plaintiff is entitled to interest at the legal rate from December 29, 2008.
