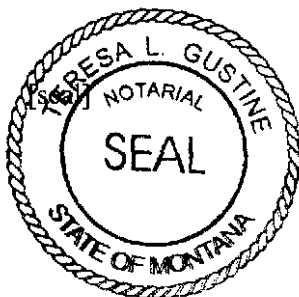
The undersigned, being of lawful age and first duly sworn, deposes and states as follows:
