**ORDER ON APPROVAL
TO SELL REAL PROPERTY**

14 A Petition for Order on Approval to Sell Real Property has been filed by
15 PERNECIA JOHNSON, Public Guardian, and Guardian of HELEN NALL, an Adult
16 Ward. A hearing of the Petition has been held. The Court having received the evidence
17 finds that notice of said hearing has been duly given as required by law; that the facts in
18 said Petition are true and correct; and that said Petition be granted.

19 I.

20 That Petitioner is the duly qualified Guardian of the Person and Estate of **HELEN**
21 **NALL**, an adult ward, that on July 29th, 2009, PERNECIA JOHNSON was appointed as
22 the Temporary Guardian of the Estate and Person of **HELEN NALL**. Pernecia Johnson
23 renewed and extended the Temporary Guardianship on August 6th, 2009. The Guardian
24 was appointed as the General Guardian of the Estate and Person of the above named
25 Ward on September 18th, 2009. She subscribed her oath of office and has since that date
26 served in that capacity.

1 II.

2 That the Petitioner is informed and believes that the Ward has real property
3 located at 5083 Tenabo Avenue, Crescent Valley, Nevada, 89821, more particularly
4 described as: APN: 002-026-14. Attached hereto as Exhibit "1" are Parcel details. Said
5 property has not been appraised.

6 III.

7 That it is necessary that said real property described be sold in order that the
8 proceeds thereof may be applied for the care and support of the Ward. It is for the
9 advantage, benefit and best interest of the Ward that said real property be sold.

10 IV.

11 That Petitioner is informed and believes that the sale of the Ward's residence is
12 necessary because the Ward is no longer capable of taking care of the residence. It is the
13 opinion of her doctors that she will not be able to care for her needs and therefore, will
14 continue to reside at Highland Manor Nursing Home.

15 V.

16 That the Petitioner is informed and believes that the property should be listed for
17 sale in "as is" condition, considering that funds are not available to clean the accumulated
18 materials by the Ward.

19 VI.

20 That the Petitioner has tentatively listed the property with a local real estate agent
21 for a period not exceeding 12 months; considering that if real property is not sold that
22 property could risk real property tax liabilities from the County or the Petitioner may
23 have to Petition this Court for abandonment of the property.

24 IT IS THEREFORE ORDERED that Pernecia Johnson, Public Guardian,
25 Guardian of the Person and Estate of HELEN NALL, Ward, is hereby authorized and
26 directed to continue with the listing of the real property for sale.

IT IS HEREBY FURTHER ORDERED that the Guardianship of the Estate to pay

upon confirmation of the sale



1 Realtor's commissions, closing costs, transfer tax, delinquent tax and other costs of sale
2 and directing execution by Petitioner of appropriate conveyances to the purchaser in
3 accordance with the foregoing, and authorizing the payment of the customary closing
4 costs and prorations incident to said sale, and any liens and encumbrances upon said
5 property.
