served in that capacity.

II.

That the Petitioner is informed and believes that the Ward has real property located at 5083 Tenabo Avenue, Crescent Valley, Nevada, 89821, more particularly described as: APN: 002-026-14. Attached hereto as Exhibit "1" are Parcel details. Said property has not been appraised.

III.

That it is necessary that said real property described be sold in order that the proceeds thereof may be applied for the care and support of the Ward. It is for the advantage, benefit and best interest of the Ward that said real property be sold.

IV

That Petitioner is informed and believes that the sale of the Ward's residence is necessary because the Ward is no longer capable of taking care of the residence. It is the opinion of her doctors that she will not be able to care for her needs and therefore, will continue to reside at Highland Manor Nursing Home.

V.

That the Petitioner is informed and believes that the property should be listed for sale in "as is" condition, considering that funds are not available to clean the accumulated materials by the Ward.

VI.

That the Petitioner has tentatively listed the property with a local real estate agent for a period not exceeding 12 months; considering that if real property is not sold that property could risk real property tax liabilities from the County or the Petitioner may have to Petition this Court for abandonment of the property.

IT IS THEREFORE ORDERED that Pernecia Johnson, Public Guardian, Guardian of the Person and Estate of HELEN NALL, Ward, is hereby authorized and directed to continue with the listing of the real property for sale.

IT IS HEREBY FURTHER ORDERED that the Guardianship of the Estate to pay

Realtor's commissions, closing costs, transfer tax, delinquent tax and other costs of sale and directing execution by Petitioner of appropriate conveyances to the purchaser in accordance with the foregoing, and authorizing the payment of the customary closing costs and prorations incident to said sale, and any liens and encumbrances upon said property.
