CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that **Barrick Gold U.S. Inc.**,

under and pursuant to the laws of the State of Nevada and of the laws of the
United States of America the following described LODE MINING CLAIM:

The name of the claim is the AGC 6.

This claim was located on 10/16/2009, by posting a Location Notice at the discovery monument.

The length of the claim is 80 feet in a East direction and 1420 feet in the opposite direction from
the monument where the Location Notice is posted, and the width is 80 feet on each side of the center of the vein
or lode, comprising in all 160 feet in length and 1500 feet in width, and generally following a east - west
course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument
