CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that RMP RESOURCES CORP., a Nevada corporation and citizen of the United States whose mailing address is 600 Lola Street, Suite 10, Helena, Montana 59601, has located the BUFF 2 lode mining claim, more particularly described below, on the 20th day of November, 2009.
