CERTIFICATE OF LOCATION LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that RMP RESOURCES CORP., a Nevada corporation and citizen of the United States whose mailing address is 600 Lola Street, Suite 10, Helena, Montana 59601, has located the BUFF 9 lode mining claim, more particularly described below, on the 20th day of November, 2009.

The claim is approximately 1500 feet long and 600 feet wide, such that 5 feet are claimed in a East direction and 1495 feet in a West direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim.
