CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **RMP RESOURCES CORP.**, a Nevada corporation and citizen of the United States whose mailing address is 600 Lola Street, Suite 10, Helena, Montana 59601, has located the **BUFF 13** lode mining claim, more particularly described below, on the 20th day of November, 2009.

The claim is approximately 1500 feet long and 600 feet wide, such that 5 feet are claimed in a East direction and 1495 feet in a West direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 2" x 2" x 4', set in the ground. The general course of the lode or vein is from the Easterly to the Westerly direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least 2" x 2" x 4', set in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the northeast corner of the claim, which is corner No. 1,

thence 600 feet south to the SE Corner (Cor. No. 2), thence 1500 feet west to the SW Corner (Cor. No. 3), thence 600 feet north to the NW Corner (Cor. No. 4), thence 1500 feet east to the Point of Beginning.

The corners were so marked with the claim number and corner location on the posts on a scribed aluminum tag attached to the post.

Bearing:

Corner No. 1 is 8767.4 feet South and 11976.8 feet West of the found GLO brass cap for the SE corner of Section 36, Township 16 North, Range 52 East, M.D.M.

The claim is located within the:


SE $\frac{1}{4}$ of Section 10, and SW $\frac{1}{4}$ of Section 10, Township 15 North, Range 52 East, M.D.M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
