CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that RMP RESOURCES CORP., a Nevada corporation and citizen of the United States whose mailing address is 600 Lola Street, Suite 10, Helena, Montana 59601, has located the BUFF 13 lode mining claim, more particularly described below, on the 20th day of November, 2009.
