At the hearing, the Court was advised by the Public Guardian of a cloud of title on the real property to be sold. The property is currently held in Joint Tenancy between the Ward, Helen Nall, and John Collins. The Court was advised of Mr. Collins's written intent to abandon the joint tenancy. The Court was also advised by the Public Guardian of the Ward's current state of health.

After hearing from all parties, the Court finds that the Ward is in poor health, which continues to deteriorate, and that in order to preserve the Ward's interest in the real property at issue, the Joint Tenancy must be severed.

GOOD CAUSE APPEARING;




