The discovery monument is found at, on, or near the North end of the claim and the length of the claim is 1295 feet in a South direction and 5 feet in the opposite direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of the vein or lode, comprising in all 1300 feet in length and 600 feet in width, and generally following a North -- South course.
