The discovery monument is found at, on, or near the <u>West</u> end of the claim and the length of the claim is 1495 feet in a <u>East</u> direction and <u>5</u> feet in the opposite direction from the monument where the Location Notice is posted, and the width is <u>300</u> feet on each side of the center of the vein or lode, comprising in all <u>1500</u> feet in length and <u>600</u> feet in width, and generally following a <u>East -- West</u> course.
