## CONCLUSIONS OF LAW

- 1. The Plaintiff is entitled to a decree granting the relief set forth in the Complaint.
- 2. The Plaintiff's exhibits 1 through 5 show a clear chain of title to the following described property:

3. The Defendant failed to remove the deed recorded by the Defendant which deed constitutes a cloud upon the Plaintiff's title to Lot 7, Block 3 of Crescent Valley Ranch & Farms Unit No.1 as per map recorded in the office of the County Recorder of Eureka County, Nevada as File No. 34081. APN: 002-026-14.

WHEREFORE, The Court enters its Judgement and Decree as to Defendant, John Collins and all other unknown persons, partnerships, corporations or other entities which may claim any interest in the real property as follows:

1. The Defendants are hereby adjudged to have no right, title interest, or lien claim whatsoever against the real property in the County of Eureka, state of Nevada and more particularly described as follows:

Lot 7, Block 3 of Crescent Valley Ranch & Farms Unit No.1 as per map recorded in the office of the County Recorder of Eureka County, Nevada as File No. 34081.

- 2. The Defendants and each of them are forever enjoined and barred from asserting any claim whatsoever against the above-described property.
