18 Upon the Stipulation for Judgment executed by the parties hereto, Plaintiff, North Star
19 Capital Acquisition, LLC, ("Plaintiff"), by and through its attorney, JEFFREY G. SLOANE,
20 ESQ., of the firm of KRAVITZ SCHNITZER SLOANE JOHNSON & EBERHARDY, and the

23 rate of 21.14 percent per annum from November 19, 2002, plus attorneys fees in the amount of

3 21.14 percent per annum from November 19, 2002, plus attorneys fees in the amount of \$183.00
4 and court costs of \$29.00, and all costs accrued after Judgment.

6 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the aforementioned
7 Judgment shall be paid as follows:

8 On or before the SEVENTEENTH (17TH) day of OCTOBER, 2008, Defendant shall pay
9 to Plaintiff FIVE HUNDRED AND 00/100 Dollars, (\$500.00), and then;

10 Beginning on or before the SEVENTEENTH (17TH) day of NOVEMBER, 2008,
11 Defendant shall pay Plaintiff TWO HUNDRED AND 00/100 Dollars, (\$200.00), per month, and
12 a like amount on or before the SEVENTEENTH (17TH) day of each month thereafter until the
13 full amount of the Judgment has been extinguished.

15 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that payments shall be
16 made payable to "KSSJE" and delivered or mailed to the offices of KRAVITZ SCHNITZER

18 200, Las Vegas, NV, 89123 and shall be received by said offices on or before the aforementioned


21 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that in the event the

3 lien rights it may have in any property of the Defendant.


4 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that pursuant to Nevada


