
Robley Berry, being duly sworn, says:

5. Notwithstanding any defect of deficiency in the foregoing affidavit, the undersigned states that it is not her intention, nor the intention of the owner of the

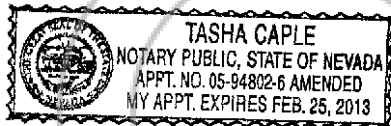
