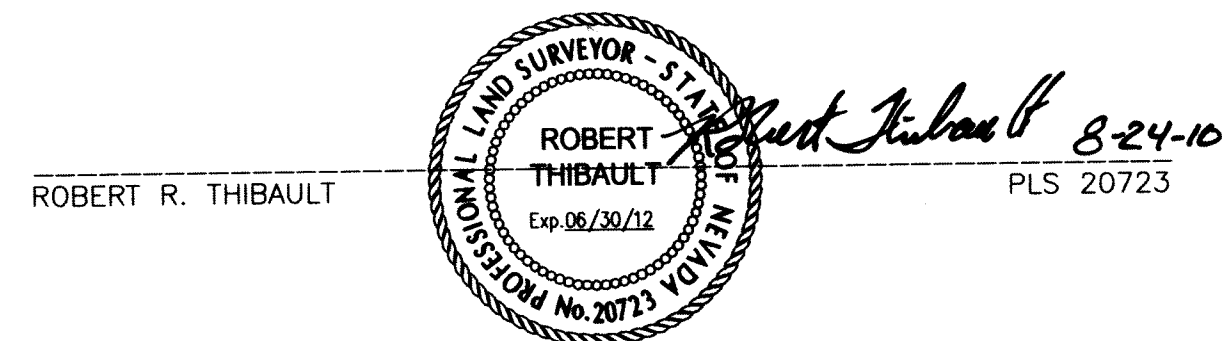


## SURVEYOR'S CERTIFICATE

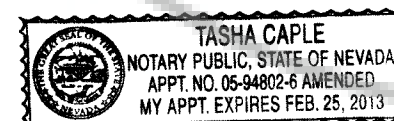

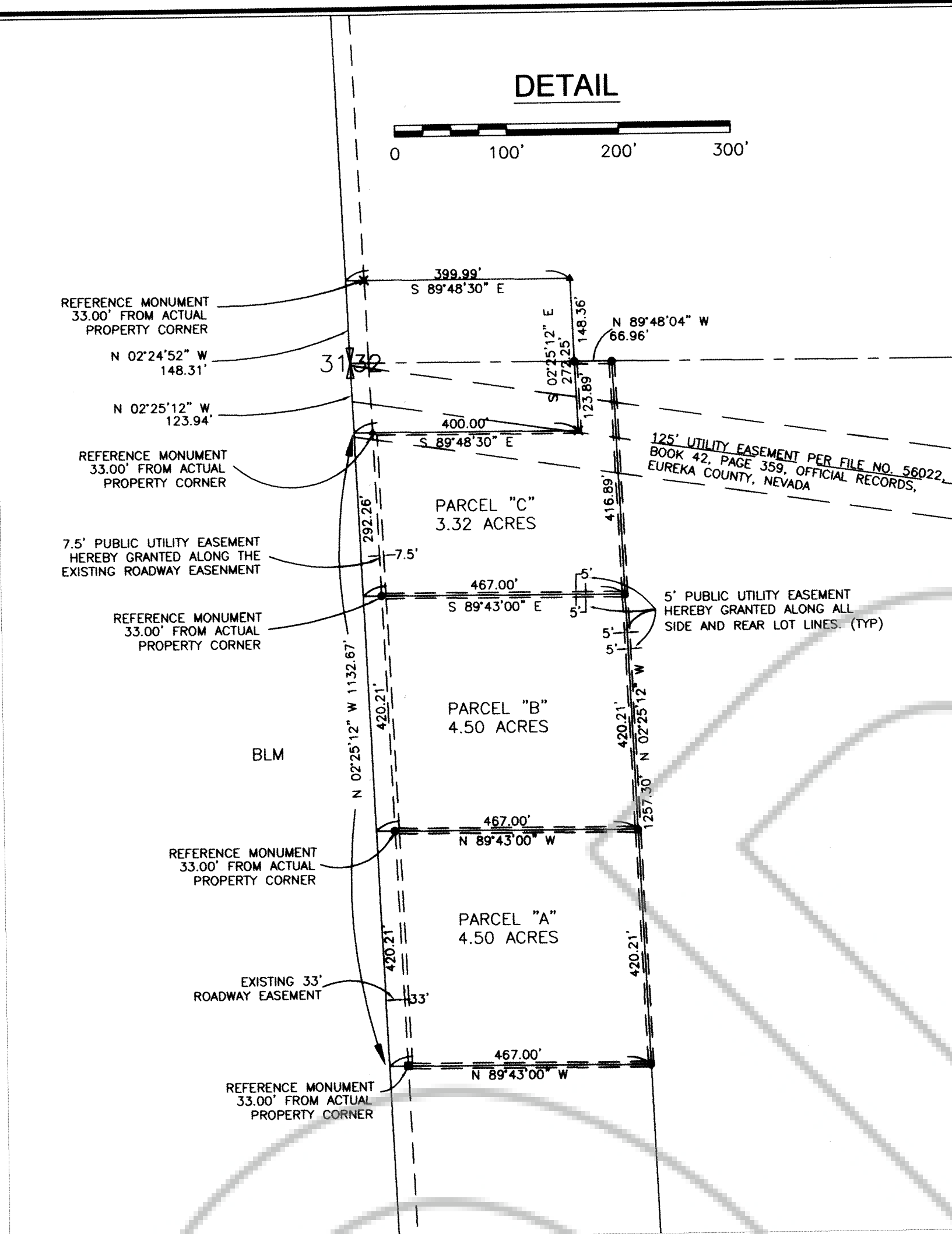

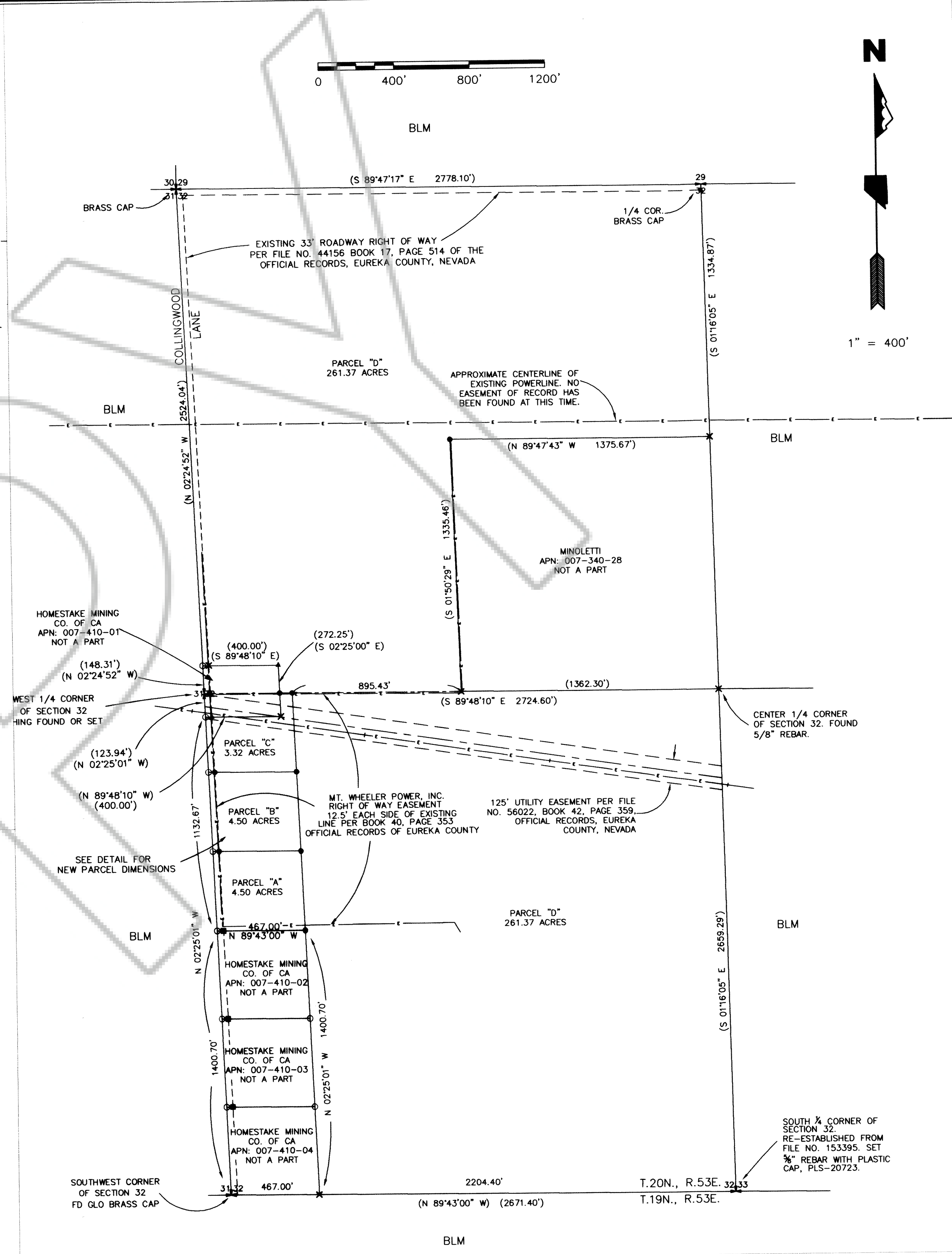
## BASIS OF BEARINGS
