CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that RMP Resources Corp., a Nevada corporation and citizen of the United States whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635, has located the DAN 23 lode mining claim, more particularly described below, after 12 noon, on September 1, 2010.

The claim is approximately 1,500 feet long and 600 feet wide, such that 5 feet are claimed in a West direction and 1495 feet in a East direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least $1\frac{1}{2}$ " x $1\frac{1}{2}$ " x 4, set one foot in the ground. The general course of the lode or vein is from the West to the East direction.
