CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that RMP Resources Corp., a Nevada corporation and citizen of the United States whose mailing address is 2778 Spokane Creek Road, East Helena. Montana 59635, has located the DAN 77 lode mining claim, more particularly described below, after 12 noon, on September 1, 2010.

The claim is approximately 1,500 feet long and 350 feet wide, such that 1495 feet are claimed S10°W and 5 feet N10°E from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 175 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4', set one foot in the ground.
