CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that RMP Resources Corp., a Nevada corporation and citizen of the United States whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635, has located the **DAN 82** lode mining claim, more particularly described below, after 12 noon, on September 4, 2010.

The claim is approximately 1,500 feet long and 600 feet wide, such that 750 feet are claimed in a **South** direction and 750 feet in a **North** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim.
