CERTIFICATE OF LOCATION LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that Lonny Hafen, agent for AMERICAN VANADIUM US INC., A Nevada Corporation whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635, located the Matt #14 lode mining claim, more particularly described below, on the 7th of November, 2010.
