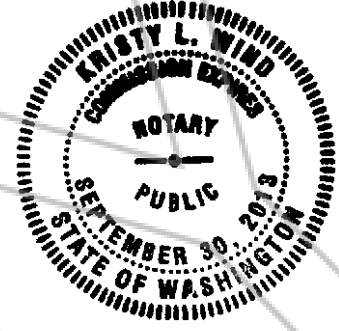


APPLICABLE LAW
