## **CERTIFICATE OF LOCATION**

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that JANELLE DIETRICH, a citizen of the United States whose mailing address is 362 Elges Way, Sparks, Nevada 89431-1343, located the BLACK HILL 3-N lode mining claim, more particularly described below, on the 21st day of February, 2011 at 11:35 o'clock AM.

The claim is approximately 1500.00 feet long and 600.00 feet wide, such that 20.00 feet are claimed in a S 44° 38′ 0″ E direction and 1480.00 feet in a N 44° 38′ 0″ W direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300.00 feet on each side of the monument of location and center line of the claim.
