CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that JANELLE DIETRICH, a citizen of the United States whose mailing address is 362 Elges Way, Sparks, Nevada 89431-1343, located the FLAT 1-N lode mining claim, more particularly described below, on the 23rd day of February, 2011 at 8:30 o'clock AM.
