CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **JANELLE DIETRICH**, a citizen of the United States whose mailing address is 362 Elges Way, Sparks, Nevada 89431-1343, located the **FLAT 10-N** lode mining claim, more particularly described below, on the 23rd day of February, 2011 at 8:35 o'clock AM.
