## CERTIFICATE OF LOCATION

### LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that JANELLE DIETRICH, a citizen of the United States whose mailing address is 362 Elges Way, Sparks, Nevada 89431-1343, located the **FLAT 11-N** lode mining claim, more particularly described below, on the **23rd** day of **February, 2011** at **8:20 o'clock AM**.

The claim is approximately **1500.00** feet long and **590.88** feet wide, such that **20.00** feet are claimed in a **N 79° 19' 51" W** direction and **1480.00** feet in a **S 79° 19' 51" E** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **295.44** feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least  $1\frac{1}{2}" \times 1\frac{1}{2}" \times 4'$ , set one foot in the ground. The general course of the lode or vein is from the **Northwesterly to Southeasterly** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least  $1\frac{1}{2}" \times 1\frac{1}{2}" \times 4'$ , set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the NE corner of the claim, which is marked corner 1, from which the SE corner of Section 36, Township 16 North, Range 52 East, M.D.B.&M. bears **N 84° 57' 49" E** a distance of **5401.77** feet:

- thence **600 feet** in a **S 0° 40' 9" W** direction to the SE Corner, which is marked corner 2,
- thence **1500 feet** in a **N 79° 19' 51" W** direction to the SW Corner, which is marked corner 3,
- thence **600 feet** in a **N 0° 40' 9" E** direction to the NW Corner, which is marked corner 4,
- thence **1500 feet** in a **S 79° 19' 51" E** direction to said corner 1, the point of beginning.

The corners were so marked on the posts with black ink.


The claim is located within the:
