CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that JANELLE DIETRICH, a citizen of the United States whose mailing address is 362 Elges Way, Sparks, Nevada 89431-1343, located the FLAT 13-N lode mining claim, more particularly described below, on the 21st day of February, 2011 at 10:05 o'clock AM.

The claim is approximately 1500.00 feet long and 600.00 feet wide, such that 20.00 feet are claimed in a N 79° 19' 51" W direction and 1480.00 feet in a S 79° 19' 51" E direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300.00 feet on each side of the monument of location and center line of the claim.
