CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **JANELLE DIETRICH**, a citizen of the United States whose mailing address is 362 Elges Way, Sparks, Nevada 89431-1343, located the **RATTLER 1-N** lode mining claim, more particularly described below, on the **23rd day of February, 2011 at 12:06 o'clock PM.**

The claim is approximately **1500.00** feet long and **600.00** feet wide, such that **20.00** feet are claimed in a **N 15° 40' 9" E** direction and **1480.00** feet in a **S 15° 40' 9" W** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300.00** feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least **1½" x 1½" x 4'**, set one foot in the ground. The general course of the lode or vein is from the **Northwesterly to Southeasterly** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least **1½" x 1½" x 4'**, set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the NE corner of the claim, which is marked corner 1, from which the SE corner of Section 36, Township 16 North, Range 52 East, M.D.B.&M. bears **S 75° 54' 47" E** a distance of **7578.28** feet:

thence **1500 feet in a S 15° 40' 9" W** direction to the SE Corner, which is marked corner 2,
thence **783.24 feet in a S 65° 40' 9" W** direction to the SW Corner, which is marked corner 3,
thence **1500 feet in a N 15° 40' 9" E** direction to the NW Corner, which is marked corner 4,
thence **783.24 feet in a N 65° 40' 9" E** direction to said corner 1, the point of beginning.

The corners were so marked on the posts with black ink.

The claim is located within the:


SE¼ quarter of Section 35, Township 16 North, Range 52 East
SW¼ quarter of Section 35, Township 16 North, Range 52 East
M.D.B.&M., Eureka County, Nevada.
