## CERTIFICATE OF LOCATION

## LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that JANELLE DIETRICH, a citizen of the United States whose mailing address is 362 Elges Way, Sparks, Nevada 89431-1343, located the RATTLER 4-N lode mining claim, more particularly described below, on the 24th day of February, 2011 at 10:07 o'clock AM.
