CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that JANELLE DIETRICH, a citizen of the United States whose mailing address is 362 Elges Way, Sparks, Nevada 89431-1343, located the CLYDE 3-N lode mining claim, more particularly described below, on the 22nd day of February, 2011 at 11:32 o'clock AM.

The claim is approximately 1500.00 feet long and 600.00 feet wide, such that 20.00 feet are claimed in a S 10° 40' 9" W direction and 1480.00 feet in a N 10° 40' 9" E direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300.00 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4', set one foot in the ground. The general course of the lode or vein is from the Southwesterly to Northeasterly direction.
