## **CERTIFICATE OF LOCATION**

## LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **JANELLE DIETRICH**, a citizen of the United States whose mailing address is 362 Elges Way, Sparks, Nevada 89431-1343, located the **CLYDE 5-N** lode mining claim, more particularly described below, on the **22nd** day of **February**, **2011 at 12:10** o'clock **PM**.

The claim is approximately 1500.00 feet long and 600.00 feet wide, such that 20.00 feet are claimed in a S 10° 40' 9" W direction and 1480.00 feet in a N 10° 40' 9" E direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300.00 feet on each side of the monument of location and center line of the claim.
