CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada corporation and citizen of the United States whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635-9793, located the **DAN** 4-N lode mining claim, more particularly described below, on the **23rd** day of **February**, **2011** at 1:15 o'clock **PM**.

The claim is approximately 1500.00 feet long and 600.00 feet wide, such that 5.00 feet are claimed in a South direction and 1495.00 feet in a North direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300.00 feet on each side of the monument of location and center line of the claim.
