NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada corporation and citizen of the United States whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635-9793, located the **DAN 5-N** lode mining claim, more particularly described below, on the 23rd day of February, 2011 at 1:25 o'clock PM.
