## CERTIFICATE OF LOCATION LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada corporation and citizen of the United States whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635-9793, located the **DAN 5-N** lode mining claim, more particularly described below, on the **23rd** day of **February, 2011** at **1:25 o'clock PM**.

The claim is approximately **1500.00** feet long and **600.00** feet wide, such that **5.00** feet are claimed in a **North** direction and **1495.00** feet in a **South** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300.00** feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least **1½" x 1½" x 4'**, set one foot in the ground. The general course of the lode or vein is from the **North to South** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least **1½" x 1½" x 4'**, set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the **NE** corner of the claim, which is marked corner **1**, from which the **SE** corner of Section **36**, Township **16** North, Range **52** East, M.D.B.&M. bears **N 81° 59' 9" E** a distance of **12989.86** feet:  
thence **1500** feet in a **S 0° 0' 0" E** direction to the **SE** Corner, which is marked corner **2**,  
thence **600** feet in a **N 90° 0' 0" W** direction to the **SW** Corner, which is marked corner **3**,  
thence **1500** feet in a **N 0° 0' 0" W** direction to the **NW** Corner, which is marked corner **4**,  
thence **600** feet in a **S 90° 0' 0" E** direction to said corner **1**, the point of beginning.

The corners were so marked on the posts with black ink.

The claim is located within the:

NE¼ quarter of Section 3, Township 15 North, Range 52 East  
SE¼ quarter of Section 3, Township 15 North, Range 52 East  
SW¼ quarter of Section 3, Township 15 North, Range 52 East  
NW¼ quarter of Section 3, Township 15 North, Range 52 East  
M.D.B.&M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within **60** days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
