CERTIFICATE OF LOCATION LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada corporation and citizen of the United States whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635-9793, located the **BUFF 25-N** lode mining claim, more particularly described below, on the **24th day of February, 2011 at 12:25 o'clock PM.**

The claim is approximately **1500.00** feet long and **600.00** feet wide, such that **900.00** feet are claimed in a **S 80° 0' 0" E** direction and **600.00** feet in a **N 80° 0' 0" W** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with **300.00** feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least **1½" x 1½" x 4'**, set one foot in the ground. The general course of the lode or vein is from the **Southeasterly to Northwesterly** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least **1½" x 1½" x 4'**, set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the **NE** corner of the claim, which is marked corner **1**, from which the **SE** corner of Section **36**, Township **16** North, Range **52** East, M.D.B.&M. bears **S 66° 10' 1" E** a distance of **8392.49** feet:

thence **600 feet in a S 10° 0' 0" W** direction to the **SE** Corner, which is marked corner **2**,
thence **1500 feet in a N 80° 0' 0" W** direction to the **SW** Corner, which is marked corner **3**,
thence **600 feet in a N 10° 0' 0" E** direction to the **NW** Corner, which is marked corner **4**,
thence **1500 feet in a S 80° 0' 0" E** direction to said corner **1**, the point of beginning.

The corners were so marked on the posts with black ink.

The claim is located within the:


NE¼ quarter of Section 35, Township 16 North, Range 52 East
