SHORT FORM OF EXPLORATION AND DEVELOPMENT AGREEMENT

THIS SHORT FORM OF EXPLORATION AND DEVELOPMENT AGREEMENT (the "Short Form") is made and entered into effective as of December 14, 2010 (the "Effective Date") by and among FRONTEER DEVELOPMENT (USA) INC., a Delaware corporation, whose address is 1031 Railroad Street, #110, Elko, Nevada 89801 ("Fronteer"), NEVADA EAGLE RESOURCES, LLC, a Nevada limited liability company, whose address is 1031 Railroad Street, #110, Elko, Nevada 89801 ("NER"), and WK MINING (USA) LTD., a Delaware corporation, whose address is 328-550 Burrard Street, Vancouver, British Columbia, Canada V6C 2B5 ("WKM").

RECITALS

- A. Fronteer or NER owns or controls certain fee lands, surface rights, mineral rights and unpatented mining claims in Lander and Eureka Counties, Nevada, as more particularly described in Exhibit A attached hereto and incorporated herein by reference (the "Projects").
- B. Fronteer, NER and WKM entered into an Exploration and Development Agreement dated effective December 14, 2010 (the "Agreement"), pursuant to which WKM acquired (i) an exclusive right to explore, evaluate and develop the Projects and (ii) the right to earn and purchase from Fronteer or NER 51% of Fronteer's or NER's interest in and to one or more Projects. Pursuant to the Agreement, if WKM acquires that interest in any of the Projects, the Parties will enter into a mining venture agreement or similar arrangement for the joint exploration, development and, if warranted, mining, production and marketing of valuable minerals from those Projects, all for the consideration and upon the terms and conditions described in the Agreement.
- C. Fronteer, NER and WKM desire to enter into this Short Form of Agreement (the "Short Form") for purposes of placing of record a notice of the Agreement.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. Grant of Exploration, Development and Related Rights. Fronteer and NER have granted and hereby grant to WKM, to the extent Fronteer and NER have the legal and contractual right to do so, the exclusive right to enter upon and use all or any part of the Projects for the purposes of determining ore reserves and mineralization, and for purposes of exploration for Valuable Minerals (as defined in the Agreement) from the Projects, including the right to enter upon the Projects for purposes of surveying, exploring, testing, sampling, trenching, bulk sampling, prospecting and drilling for Valuable Minerals, and to use and construct buildings, roads, power and communication lines, and to use so much of the surface of the Projects in such manner as is necessary to the enjoyment of any of the rights or privileges of WKM hereunder or otherwise reasonably necessary to effect the purposes of the Agreement.
- 2. Grant of Right to Acquire an Interest in the Projects. Fronteer and NER have granted and hereby grant to WKM, during the First Earn-In Period (as defined in the Agreement), the exclusive right to acquire an undivided 51% of Fronteer's or NER's interest in one or more Projects upon the completion of certain obligations set forth in the Agreement.
- 3. Agreement to Enter into Joint Venture Agreement or LLC Operating Agreement. In addition to the rights granted in the Agreement as described in paragraph 1 above, Fronteer, NER and WKM have agreed and do hereby agree that, subject to the terms and conditions set forth in the Agreement, upon WKM's acquisition of an undivided 51% of Fronteer's or NER's interest in a Project they will enter into a Mining Venture Agreement or an LLC Operating Agreement (as described in the Agreement) governing operations at such Project.
- 4. Term. Unless sooner terminated as provided in the Agreement, the term of the Agreement shall run from and after the Effective Date until such time as WKM timely incurs required minimum amounts of Exploration and Development Expenditures (as defined in the Agreement) and the parties execute the Venture Agreement or the LLC Operating Agreement, or until sooner terminated as set forth in the Agreement, but in any event not later than December 14, 2014.
- 5. <u>Title to After-Acquired and Additional Interests</u>. The Agreement applies and extends to any further or additional right, title, interest or estate heretofore or hereafter acquired by Fronteer or NER or any affiliate or subsidiary of Fronteer or NER during the First Earn-In Period in or to the Projects or any part thereof, and to any interest in real property acquired by either Fronteer or NER or WKM wholly or partially within one mile of the exterior boundaries of each Project, as those boundaries are currently configured, from and after the Effective Date, as depicted on the attached Exhibit A-1; excluding, however, (i) any interests in real property wholly or partially within the Area of Interest and owned or held of record by Rubicon Nevada Corp. or any Affiliate as of the Effective Date, and (ii) any interests in real property wholly or partially within the Area of Interest which are owned or held of record by Fronteer or NER or any Affiliate but which are not specifically included in the Projects.
- 6. <u>Successors and Assigns</u>. Subject to the provisions of paragraph 7 below, all of the terms, provisions and conditions of the Agreement and this Short Form are, and shall be, binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.

- 7. <u>Assignability</u>. WKM shall have no right to assign its interest in the Agreement to any third party without the prior written consent of Fronteer or NER, which consent shall not be unreasonably withheld or delayed. Any third party to whom any interest in the Agreement or the Projects is assigned or conveyed shall agree in writing to be bound by all of the terms and conditions contained in the Agreement.
- 8. <u>Non-Responsibility</u>. During the Earn-In Period (as defined in the Agreement), Fronteer or NER may post and record notices of non-responsibility on or with respect to WKM's activities on the Projects as allowable under applicable laws.
- 9. Additional Terms. The Agreement contains additional clauses and various other provisions, and reference is made to the Agreement for such other terms and conditions as govern the Agreement, which terms and conditions are by reference made a part hereof. Nothing in this Short Form shall limit or affect the rights and duties of the parties under the Agreement. Requests for information regarding the Agreement should be made to the parties at the addresses set forth above. Capitalized terms used but not defined herein shall have the meaning ascribed to them in the Agreement.
- 10. <u>Counterparts</u>. This Short Form may be extended in multiple counterparts, and all such counterparts taken together shall be deemed to constitute a single document.




