CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada Corporation whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635, located the Jct. No. 1 lode mining claim, more particularly described below, on the 30th day of March, 2011.

The claim is approximately 1,500 feet long and 600 feet wide, such that 35 feet are claimed in a N 13° 0° 0" E direction and 1465 feet in a S 13° 0' 0" W direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 fect on each side of the monument of location and center line of the claim.
