CERTIFICATE OF LOCATION
LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada Corporation whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635, located the **Jct. No. 3** lode mining claim, more particularly described below, on the **30th** day of **March, 2011**.

The claim is approximately 1,500 feet long and 600 feet wide, such that **80 feet** are claimed in a **S 75° 0' 0" E** direction and **1420 feet** in a **N 75° 0' 0" W** direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4', set one foot in the ground. The general course of the lode or vein is from the **Southeasterly to Northwesterly** direction.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least 1½" x 1½" x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the **SW** corner of the claim, which is marked **SW Cor. Jct. No. 3**, from which the protracted **NW** corner of Section 31, Township 17 North, Range 54 East, MDM bears **S 75° 0' 0" E** a distance of **705 feet**:

thence **600 feet N 15° 0' 0" E** to the **NW** Corner, which is marked **NW Cor. Jct. No. 3**,
thence **1500 feet S 75° 0' 0" E** to the **NE** Corner, which is marked **NE Cor. Jct. No. 3**,
thence **600 feet S 48° 0' 0" W** to the **SE** Corner, which is marked **SE Cor. Jct. No. 3**,
thence **1500 feet N 42° 0' 0" W** to said **SW Cor. Jct. No. 3**, the point of beginning.

The corners were so marked on the posts with black ink, or were marked on a scribed aluminum tag attached to the post.

The claim is located within the:

SW¼ quarter of Section 30, Township 17 North, Range 54 East

NW¼ quarter of Section 31, Township 17 North, Range 54 East

M.D.B.&M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
