CERTIFICATE OF LOCATION

LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada Corporation whose mailing address is 2778 Spokane Creek Road, East Helena, Montana 59635, located the Jct. No. 3 lode mining claim, more particularly described below, on the 30th day of March, 2011.

The claim is approximately 1,500 feet long and 600 feet wide, such that 80 feet are claimed in a S 75° 0' 0" E direction and 1420 feet in a N 75° 0' 0" W direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4', set one foot in the ground.
