**AFFIDAVIT OF PAYMENT OF FEES FOR MINING CLAIMS HELD
IN NEVADA PURSUANT TO NRS 517.187**

This document does not contain the personal information of any person.

The undersigned declares under penalty of perjury:

On **October 28, 2010**, **Great American Minerals** ("Owner"), the owner of the unpatented mining claims (the "claims") for which additional mining claims fees are submitted with this Affidavit, recorded, or caused to be recorded, its Affidavit and Declaration Of Claims Held In Nevada Pursuant To NRS 517.187, Document No. **0215838**, for the number of claims held in Nevada on the date of Owner's recording made in this county pursuant to NRS 517.230(3), as follows.

- Less than 11 claims (Fee is \$0 per claim)
- Not less than 11 and not more than 199 (Fee is \$70 per claim)
- Not less than 200 and not more than 1,299 (Fee is \$85 per claim)
- Not less than 1,300 (Fee is \$195 per claim)

The original Affidavit which Owner recorded was incorrect because it grouped all of the claim blocks held by Great American Minerals together. It is the desire of the Owner to record each claim block separately for record keeping purposes. The correct number of claims recorded on this document is **82** and the correct amount of the additional fees is **\$85 per claim**. By this Affidavit, Owner amends the original Affidavit, Document No. **0215838**.

The total of the additional mining claim fees payable pursuant to NRS 517.187 for Owner's claims held in this county is **\$6,970**, not including the recording fees.

The names of and the Bureau of Land Management mining claim serial numbers for Owner's claims are stated in the list attached to this Affidavit.

The additional mining claims fees imposed under NRS 517.187 are a tax on unpatented claims which violates Section 1 of Article X of the Nevada Constitution because only the net proceeds of mines and mining claims may be taxed and because the fees are not reasonable and uniform as required under the Nevada Constitution and the Constitution of the United States. The additional mining claim fees are an

unconstitutional tax. Owner intends to seek a refund of the fees submitted with this Affidavit if (a) NRS 517.187 is declared to be unconstitutional by a court of the State of Nevada or the United States; (b) NRS 517.187 is repealed; or (c) NRS 517.187 is amended to reduce the amount of the additional mining claim fees. The additional mining claim fees submitted with this Affidavit are paid under protest as provided in NRS 361.420 and NRS 353.110.

When Owner recorded Owner's original Affidavit, Owner paid NONE of the additional mining claim fees. Refer to Document No. **0215838**. The additional mining claim fees submitted with this Affidavit are in the amount of **\$6,970**.
