On **October 28, 2010**, **Platte River Gold (US) Inc.** ("Owner"), the owner of the unpatented mining claims (the "claims") for which additional mining claims fees are submitted with this Affidavit, recorded, or caused to be recorded, its Affidavit and Declaration Of Claims Held In Nevada Pursuant To NRS 517.187, Document No. **0215822**, for the number of claims held in Nevada on the date of Owner's recording made in this county pursuant to NRS 517.230(3), as follows.


The original Affidavit was incorrect because it listed Great American Minerals as the Owner, stated that the number of claims was 41 and that the additional fees were in the amount of \$3,485. By this Affidavit, Owner amends the original Affidavit to reflect the correct Owner, **Platte River Gold (US) Inc.**, the correct number of claims filed with this document is **26** and the correct amount of additional fees is **\$1,820**. By this Affidavit, Owner amends the original Affidavit.

The names of and the Bureau of Land Management mining claim serial numbers for Owner's claims are stated in the list attached to this Affidavit.

The additional mining claims fees imposed under NRS 517.187 are a tax on unpatented claims which violates Section 1 of Article X of the Nevada Constitution because only the net proceeds of mines and mining claims may be taxed and because the fees are not reasonable and uniform as required under the Nevada Constitution and the Constitution of the United States. The additional mining claim fees are an unconstitutional tax. Owner intends to seek a refund of the fees submitted with this Affidavit if (a) NRS 517.187 is declared to be unconstitutional by a court of the State of Nevada or the United States; (b) NRS 517.187 is repealed; or (c) NRS 517.187 is amended to reduce the amount of the additional mining claim fees. The additional mining claim fees submitted with this Affidavit are paid under protest as provided in NRS 361.420 and NRS 353.110.

When Great American Minerals recorded the original Affidavit none of the additional mining claim fees were paid. Refer to Document No. **0215822**. The additional mining claim fees submitted with this Affidavit are in the amount of **\$1,820**.
