This claim is irregular in shape and runs from the location monument on which this location notice is posted approximately 20 feet in a west direction to the west end line and 1480 feet in a east direction to the east end line. The bearing and approximate distance between the six corners of the claim are: Beginning at the northwest corner, 750 feet in an east direction to corner 2, then 244 feet in a south direction to corner 3, then 750 feet in a east direction to corner 4, then 356 feet in a south direction to corner 5, then 1500 feet in a west direction to corner 6, then 600 in a north direction to corner 1. The claim boundary between corners 2 and 3 and between corners 3 and 4 is defined to include all locatable lands up to the southern and western boundary of State Selection 22 where all attempts were made to place monuments on the patent boundary line without entry or location on lands not open to mineral entry.

As erected on the ground, each corner monument consists of 1 1/2" by 1 1/2" by 4" wooden posts marked with metal tags containing the claim name, corner location, and general location map. The work of location consisted of making a claim map as provided in NRS 517.040.
