CERTIFICATE OF LOCATION**

Lode Mining Claim



NOTICE IS HEREBY GIVEN that **Barrick Gold U.S. Inc.**,  
136 E. South Temple, Suite 1800, Salt Lake City, UT 84111, hereby claims  
under and pursuant to the laws of the State of Nevada and of the laws of the  
United States of America the following described **LODE MINING CLAIM**:

The name of the claim is the CJ 30. This claim was located on September 17, 1978, by  
posting a Location Notice at the discovery monument.

The length of the claim is 1490 feet in a easterly direction and 10 feet in the opposite  
direction from the monument where the Location Notice is posted, and the width is 300 feet on each  
side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and  
generally following an east/west course.

The exterior boundaries are distinctly marked by six substantial monuments. Each corner  
monument consists of a 4" x 4" x 4 1/2 feet wooden post with metal tags attached, scribed with claim name  
and corner description, set one foot in the ground. The boundaries can be readily traced by beginning at  
corner No. 1, the Northwest corner:

thence 750 feet east to the North Side Center post No. 2,  
thence 750 feet east to the Northeast Corner post No. 3,  
thence 600 feet south to the Southeast Corner post No. 4,  
thence 750 feet west to the South Side Center post No. 5,  
thence 750 feet west to the Southwest Corner post No. 6,  
thence 600 feet north to the Northwest Corner post No. 1, the point of beginning.

Said claim is located in the:

NE 1/4 of Section 13 Township 25 North, Range 49 East, MDB&M, Eureka County, Nevada

The boundaries of said claim were defined by law within 20 days from the date of posting of the  
Notice of Location. The location work, consisting of the making and filing of maps and the payment of  
fees prescribed by NRS 517.040, was completed by the date of recordation of this certificate.

The original Certificate of Location recorded on 11-27-1978 at Book 67, Page 128 of the  
Official Records of Eureka County, Nevada and filed in the Bureau of Land Management with the Serial  
Number of NMC-44785, is hereby amended. The record of location is hereby amended, and a copy of  
this Amended Certificate of Location has been posted on the claim this 19 of April, 2011.
