CERTIFICATE OF LOCATION**

Lode Mining Claim



NOTICE IS HEREBY GIVEN that **Barrick Gold U.S. Inc.**,
136 E. South Temple, Suite 1800, Salt Lake City, UT 84111, hereby claims
under and pursuant to the laws of the State of Nevada and of the laws of the
United States of America the following described **LODE MINING CLAIM**:

The name of the claim is the CKN 29 This claim was located on April 19, 1994, by posting
a Location Notice at the discovery monument.

The length of the claim is 20 feet in a easterly direction and 1480 feet in the opposite
direction from the monument where the Location Notice is posted, and the width is 300 feet on each
side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and
generally following an east/west course.

The exterior boundaries are distinctly marked by six substantial monuments. Each corner
monument consists of a 2" x 2" x 4 1/2 feet wooden post with metal tags attached, scribed with claim name
and corner description, set one foot in the ground. The boundaries can be readily traced by beginning at
corner No. 1, the Northeast corner:

thence 600 feet south to the Southeast Corner post No. 2,
thence 1500 feet west to the Southwest Corner post No. 3,
thence 600 feet north to the Northwest Corner post No. 4,
thence 1500 feet east to the Northeast Corner post No. 1, the point of beginning.

NW 1/4 of Section 18 Township 25 North, Range 50 East, MDB&M, Eureka County, Nevada
