## **AMENDED** CERTIFICATE OF LOCATION

Lode Mining Claim

NOTICE IS HEREBY GIVEN that Barrick Gold U.S. Inc., 136 E. South Temple, Suite 1800, Salt Lake City, UT 84111, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described LODE MINING CLAIM:
