## **CERTIFICATE OF LOCATION**

## LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada Corporation whose mailing address is P.O. Box 983, Eureka, Nevada, 89316, located the Flow 3 lode mining claim, more particularly described below, on the 28<sup>th</sup> day of April, 2011.

The claim is approximately 1,500 feet long and 600 feet wide, such that 20 feet are claimed in a N 46° E direction and 1480 feet in a S 46° W direction from the point of discovery (monument of location), at which a Notice of Location was duly posted, together with 300 feet on each side of the monument of location and center line of the claim.
