## CERTIFICATE OF LOCATION LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that AMERICAN VANADIUM US INC., a Nevada Corporation whose mailing address is P.O. Box 983, Eureka, Nevada, 89316, located the Flow 5 lode mining claim, more particularly described below, on the 28th day of April, 2011.
