CERTIFICATE OF LOCATION

PLACER MINING CLAIM

NOTICE IS HEREBY GIVEN that **AMERICAN VANADIUM US INC.**, a Nevada Corporation whose mailing address is P.O. Box 983, Eureka, Nevada, 89316, located the **Dry 3** placer mining claim, more particularly described below, on the **20th** day of **May, 2011**.

The claim is approximately 1,320 feet long and 660 feet wide, such that **1,320** feet are claimed in a Southerly direction from the northern boundary at the NW corner of the claim (monument of location), at which a Notice of Location was duly posted. The monument of location upon which the Notice of Location was posted is a wood post measuring at least 1½" x 1½" x 4', set one foot in the ground.

The exterior boundaries of the claim are distinctly marked by four wooden posts measuring at least 1½" x 1½" x 4', set one foot in the ground, one at each corner. The boundaries of the claim are described as follows: Beginning at the **NW** corner of the claim, which is marked corner Dry 3 NW, from which the **SW** corner of Section 6, Township 15 North, Range 53 East, MDM bears **West** a distance of **1980** feet:

thence **660 feet East** to the **NE** Corner, which is marked corner Dry 3 NE,
thence **1,320 feet South** to the **SE** Corner, which is marked corner Dry 3 SE,
thence **660 feet West** to the **SW** Corner, which is marked corner Dry 3 SW,
thence **1,320 feet North** to said corner Dry 3 NW, the point of beginning.

The corners were so marked on the posts with black ink, or were marked on a scribed aluminum tag attached to the post.

The claim is located within the:

NE quarter of Section 7, Township 15 North, Range 53 East,
NW quarter of Section 7, Township 15 North, Range 53 East,
M.D.B.&M., Eureka County, Nevada.

The boundaries of the claim were defined as required by law within 60 days from the date of posting of the Notice of Location. The work of location consisted of making the claim map as provided in N.R.S. § 517.040.
